REVISED IBT LOCAL UNION 439

Plan Summary for Election of Delegates and Alternate Delegates to the IBT Convention MEETING TO BE HELD VIA ZOOM. AN IN-PERSON MEETING WILL NOT BE HELD.

IBT LU 439 is entitled to elect 7 delegate and has chosen to elect 2 alternate delegates to the June 2021 IBT International Convention. The expenses of all of the delegates and alternate delegates will be paid by the Local. The Election Supervisor has approved the plan for conducting nominations and elections. The important details of the plan are summarized below.

NOMINATION

When & Where: Due to COVID-19 restrictions, the meeting will be conducted virtually, via Zoom, on Wednesday, February 17, 2021 at 7:00 PM. An in-person meeting will not be held. IBT LU 439 will post an Amended Nominations Notice on bulletin boards and IBT LU 439 Facebook page with additional instructions for attending the meeting. Who Can Attend: Any active member may attend the meeting.

Who Can Run: A member must be in continuous good standing for a period of twenty-four months prior to the month of February, 2021.

Who Can Nominate: Members in good standing (full dues paid through January, 2021) may nominate or second the nomination of a candidate or slate of candidates.

Nominations: Nominations may be made or seconded orally at the virtual nomination meeting. **MEMBERS ARE STRONGLY URGED to submit nominations, seconds and acceptances in writing** to the Secretary-Treasurer at IBT Local 439, 1531 E. Fremont Street, Stockton, CA 95205 or emailed to info@unilect.com prior to the deadline of 5:00 PM on Wednesday, February 17, 2021. It shall be signed by the member submitting the nomination or second and shall provide his/her complete mailing address. The submitting individual may also choose to provide the last four digits of his/her SSN.

Candidate Acceptance: A member may accept nomination in person, or if absent from the meeting, by furnishing a written acceptance to the presiding officer not later than the time the member is nominated. It shall be signed by the member submitting the acceptance and shall provide his/her complete mailing address. The submitting individual may also choose to provide the last four digits of his/her SSN.

Eligibility Deadline: Dues must be paid at IBT Local 439, 1531 E. Fremont Street, Stockton, CA 95205 by 5:00 PM on Wednesday, February 17, 2021.

Mail Balloting: All members should receive a ballot at their home address before Monday, March 29, 2021. Any member not receiving a ballot by that date should request a ballot by calling IBT 439.

Voting Deadline: VOTED BALLOT MUST BE RETURNED BY MAIL IN TIME FOR RECEIPT NO LATER THAN 9:00 AM ON THURSDAY, APRIL 15, 2021.

Eligibility Deadline: Dues must be paid at IBT Local 439, 1531 E. Fremont Street, Stockton, CA 95205 by 5:00 PM on Wednesday, April 14, 2021.
